## AGREEMENT FOR DJ SERVICES

1. CLIENT engages DJ to provide professional DJ services, to include music, lights and a master of ceremonies to coordinate the entertainment, at the following Event Location:

3. As consideration for the performance of the DJ service CLIENT agrees to pay to DJ the following:

4. **Payment in full of the Performance fee shall be made no later than 30 days prior to the date of the event.** Should CLIENT fail to pay the performance fee in full by such date, they will be deemed to have breached this Agreement and DJ shall have no further obligation hereunder. In the event of a breach of this Agreement by CLIENT, DJ shall retain the deposit as liquidated damages. \_\_\_\_\_ (init)

5. The agreement of the DJ to perform is subject to accidents, acts of god, and other events beyond the control of DJ. In the event that DJ is unable to perform as a result of such circumstances, DJ's liability shall be limited to a complete refund of all monies received. DJ shall in no instance be liable for indirect or consequential damages of any type.

6. CLIENT agrees to provide adequate electrical service and other suitable physical and environmental conditions. DJ shall not be responsible for any inability to perform due to lack of adequate facilities and/or conditions.

CLIENT shall provide suitable working conditions to include a 6-foot by 6-foot area for setup, space for speakers and lights stands, and a minimum of one 15-20 amp circuit outlet from

a reliable power source within 25 feet of the setup area. **(DESCRIBE OTHER CONDITIONS)**

8. It is understood that if this event is outdoors, DJ's compensation is in no way affected by inclement weather. DJ reserves the right, in good faith, to stop or cancel the performance should the weather pose a potential danger to DJ, their equipment, or the public. In such event, DJ shall be deemed to have earned its total performance fee.

9. DJ reserves the right to cease performance in the event of circumstances deemed to present a threat or implied threat of injury or harm to DJ's staff or equipment. In order to prevent equipment damage or liability arising from accidental injury to any individual attending the event, DJ reserves the right to deny any guest access to DJ's equipment.

10. CLIENT agrees to defend, indemnify, assume liability for and hold DJ, its agents and employees harmless from any and all responsibility, liability or claim for damages or injuries to persons and property arising from this agreement.

11. The parties agree that this agreement represents the entire agreement between the parties and no statement, promises, or inducements made by any party hereto not contained in this agreement shall be valid or binding.

12. In the event that a civil action arises in an effort to enforce any provision of this agreement, the prevailing party shall be entitled to recover its reasonable attorney fees and costs.

13. **It is the responsibility of the CLIENT to contact Tradewind 30 days prior to event to make final payment and return completed forms.**
